<b>What is the overall deductible?</b>	\$0 at Indian Health Care Provider (IHCP) or with IHCP <a href="#">referral</a> at Non-IHCP; or \$1,500/person or \$3,000/family for Non-IHCP In-Network <a href="#">Providers</a> .	Generally, you must pay all of the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. **Does this plan provide Minimum Essential Coverage? Yes.**

Minimum Essential Coverage generally includes plans, health insurance available through the Marketplace or other individual market policies, Medicare, Medicaid, CHIP, TRICARE, and certain other coverage. If you are eligible for certain types of Minimum Essential Coverage, you may not be eligible for the premium tax credit.
