<b>What is the overall deductible?</b>	\$0 at Indian Health Care Provider (IHCP) or with IHCP <a href="#">referral</a> at Non-IHCP; or \$5,000/person or \$10,000/family for Non-IHCP <a href="#">In-Network Providers</a> .	Generally, you must pay all of the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay.
